


# HERITAGE COUNCIL DETERMINATION

## **DETERMINATION**

The Heritage Council of Victoria determined on 1 August 2024 that, in accordance with section 62 of the *Heritage Act 2017* (Vic) ('the Act'), the above Place is to be amended in the Victorian Heritage Register ('VHR') by:

• including additional land, so as to comprise **all** of the Place show hatched on Diagram 1458 encompassing all of Lot 1 of Title Plan 132016K:





- determining categories of works or activities which may be carried out in relation to the Place for which a permit is not required ('permit exemptions') in accordance with the **Annexure 1**; and
- amending the reasons why the Place is included in the VHR based on the Heritage Council criteria specifically to include reference to Criterion D.

### **BACKGROUND**

The cultural heritage significance of the Former Eaglehawk East Methodist Church was recognised when it was included in the Register of Government Buildings in 1984. Its State-level cultural heritage significance was confirmed in 1998.

On 24 April 2024 the Executive Director made and accepted an application to amend the registration of the Place to ensure it is consistent with current practices under the Act.

#### BASIS OF RECOMMENDATION

The Executive Director recommended that the Heritage Council amend this registration to include additional land in accordance with sub-sections 40(4)(c) (i) and (ii) of the Act. Reasons for this recommendation were set out in a Recommendation report ("Recommendation") received by the Heritage Council, in relation to both sub-sections being:

- The land proposed for inclusion is and has been used in conjunction with the former Eaglehawk East Methodist Church. The land proposed for inclusion has been used in conjunction with the place for over 150 years.
- If any of the land were developed, there is potential for the development to impact upon the setting of the simple temple form and substantially reduce the State-level cultural heritage significance of the Place.
- Including additional land will ensure that all works are managed through an approvals process consistent across the entirety of this Place and would provide certainty for all parties.
- The current extent is limited to the footprint of the building and is insufficient to protect, conserve and allow for a proper understanding of the Place.
- Without an approval process, the simple Tuscan order, hexastyle temple and the stripped classical elements could potentially be obstructed or diminished by new buildings which, depending upon their siting, height, form, scale and materials, could affect the setting or context of the Place.
- Inclusion of an area of land around the building will enable works or activities that could potentially impact the conservation of the building, such as drainage, landscaping and paving, to be managed under an approval process.
- Inclusion of an area around the building provides a setting for the Place.



The Executive Director also recommended that the Heritage Council amend the reasons why the Place is included in the VHR based on the Heritage Council criteria to include reference to Criterion D as the current statement of significance is extremely limited and does not specify the criteria under which the former Eaglehawk East Methodist Church was registered. The Recommendation submits that the Place's architecture is a notable example of classical temple design, appropriate to the non-conformist views of the Primitive Methodist Church and should be registered under Criterion D.

#### SUBMISSIONS

No public or authority submissions were received by the Heritage Council in relation to this matter.

### **COUNCIL'S FINDINGS**

The Heritage Council accepts the Executive Director's Recommendation and the rationale provided in the Recommendation.

The amendment to include additional land to the current Registration corresponds with historical uses of the Place, the additional land having been used in conjunction with the former Eaglehawk East Methodist Church for over 150 years.

The current extent of land is confined. It does not afford sufficient protection of the Place. The inclusion of the entire parcel which the Church is situated on will provide a sufficient setting to conserve and manage further development. If any of the land were developed, there is potential for the development to impact upon the setting of the Place and substantially reduce its State-level cultural heritage significance.

The current statement of significance is limited and does not specify the criteria under which the former Eaglehawk East Methodist Church was registered. It is appropriate to register the former Eaglehawk East Methodist Church under Criterion D, as its architecture is a notable example of classical temple design, appropriate to the non-conformist views of the Primitive Methodist Church.

The proposed categories of works or activities which may be carried out in relation to the Place for which a permit is not required (specific permit exemptions) would not harm the cultural heritage significance of the Place.

# **ANNEXURE 1 – PERMIT EXEMPTIONS**

The categories of works or activities which may be carried out in relation to the Place for which a permit is not required ('permit exemptions') to be included, pursuant to section 49(3)(a) of the *Heritage Act 2017* (Vic) as follows:

### Introduction

A <u>heritage permit</u> is required for all works and activities undertaken in relation to VHR places and objects. Certain worksand activities are <u>exempt from a heritage permit</u>, if the proposed works will not harm the cultural heritage significance of the heritage place or object.

## **Permit Policy**

It is recommended that a Conservation Management Plan is utilised to manage the place in a manner which respects its cultural heritage significance.

### **Permit Exemptions**

### **General Exemptions**

General exemptions apply to all places and objects included in the Victorian Heritage Register (VHR). General exemptionshave been designed to allow everyday activities, maintenance and changes to your property, which don't harm its cultural heritage significance, to proceed without the need to obtain approvals under the Heritage Act 2017.

Places of worship: In some circumstances, you can alter a place of worship to accommodate religious practices without a permit, but you must notify the Executive Director of Heritage Victoria before you start the works or activities at least 20 business days before the works or activities are to commence.

Subdivision/consolidation: Permit exemptions exist for some subdivisions and consolidations. If the subdivision or consolidation is in accordance with a planning permit granted under Part 4 of the Planning and Environment Act 1987 and the application for the planning permit was referred to the Executive Director of Heritage Victoria as a determining referral authority, a permit is not required.

Specific exemptions may also apply to your registered place or object. If applicable, these are listed below. Specific exemptions are tailored to the conservation and management needs of an individual registered place or object and set outworks and activities that are exempt from the requirements of a permit. Specific exemptions prevail if they conflict with general exemptions.

## **Specific Exemptions**

The works and activities below are not considered to cause harm to the cultural heritage significance of the FormerEaglehawk East Methodist Church subject to the following guidelines and conditions:

### Guidelines

- 1. Where there is an inconsistency between permit exemptions specific to the registered place or object ('specific exemptions') established in accordance with either section 49(3) or section 92(3) of the Act and general exemptionsestablished in accordance with section 92(1) of the Act specific exemptions will prevail to the extent of any inconsistency.
- 2. In specific exemptions, words have the same meaning as in the Act, unless otherwise indicated. Where there is aninconsistency between specific exemptions and the Act, the Act will prevail to the extent of any inconsistency.
- 3. Nothing in specific exemptions obviates the responsibility of a proponent to obtain the consent of the owner of the registered place or object, or if the registered place or object is situated on Crown Land the land manager as defined in the *Crown Land (Reserves) Act 1978*,



prior to undertaking works or activities in accordance with specific exemptions.

- 4. If a Cultural Heritage Management Plan in accordance with the Aboriginal Heritage Act 2006 is required for works covered by specific exemptions, specific exemptions will apply only if the Cultural Heritage Management Plan has been approved prior to works or activities commencing. Where there is an inconsistency between specific exemptions and a Cultural Heritage Management Plan for the relevant works and activities, Heritage Victoria must be contacted for advice on the appropriate approval pathway.
- 5. Specific exemptions do not constitute approvals, authorisations or exemptions under any other legislation, Local Government, State Government or Commonwealth Government requirements, including but not limited to the *Planningand Environment Act 1987*, the *Aboriginal Heritage Act 2006*, and the *Environment Protection and Biodiversity Conservation Act 1999* (Cth). Nothing in this declaration exempts owners or their agents from the responsibility to obtain relevant planning, building or environmental approvals from the responsible authority where applicable.
- 6. Care should be taken when working with heritage buildings and objects, as historic fabric may contain dangerous and poisonous materials (for example lead paint and asbestos). Appropriate personal protective equipment should be wornat all times. If you are unsure, seek advice from a qualified heritage architect, heritage consultant or local Council heritage advisor.
- 7. The presence of unsafe materials (for example asbestos, lead paint etc) at a registered place or object does not automatically exempt remedial works or activities in accordance with this category. Approvals under Part 5 of the *Heritage Act 2017* must be obtained to undertake works or activities that are not expressly exempted by the belowspecific exemptions.
- 8. All works should be informed by a Conservation Management Plan prepared for the place or object. The Executive Director is not bound by any Conservation Management Plan and permits still must be obtained for works suggested any Conservation Management Plan.

#### **Conditions**

- 1. All works or activities permitted under specific exemptions must be planned and carried out in a manner whichprevents harm to the registered place or object. Harm includes moving, removing or damaging any part of the registered place or object that contributes to its cultural heritage significance.
- 2. If during the carrying out of works or activities in accordance with specific exemptions original or previously hidden orinaccessible details of the registered place are revealed relating to its cultural heritage significance, including but notlimited to historical archaeological remains, such as features, deposits or artefacts, then works must cease and Heritage Victoria notified as soon as possible.
- 3. If during the carrying out of works or activities in accordance with specific exemptions any Aboriginal cultural heritageis discovered or exposed at any time, all works must cease and the Secretary (as defined in the *Aboriginal Heritage Act 2006*) must be contacted immediately to ascertain requirements under the *Aboriginal Heritage Act 2006*.
- 4. If during the carrying out of works or activities in accordance with specific exemptions any munitions or other potentially explosive artefacts are discovered, Victoria Police is to be immediately alerted and the site is to be immediately cleared of all personnel.
- 5. If during the carrying out of works or activities in accordance with specific exemptions any suspected human remains are found the works or activities must cease. The remains must be left in place and protected from harm or damage. Victoria Police and the State Coroner's Office must be notified immediately. If there are reasonable grounds to believethat the remains are Aboriginal, the State Emergency Control Centre must be immediately notified on 1300 888 544, and, as required under s.17(3)(b) of the Aboriginal Heritage Act 2006, all details about the location and nature of the human remains must be provided to the Secretary (as defined in the Aboriginal Heritage Act 2006.



### **Exempt works and activities**

- 1. Landscape/ outdoor areas:
  - i) Installation, repair and replacement of shade sail fabric and supporting structures in the same locations.
  - ii) Replacement of playground equipment and outdoor furniture in the same general location.
  - iv) Removal, replacement or pruning of all trees and shrubs.
  - v) Removal, replacement and installation of new ground surfacing treatments (for example, asphalt, safety matting) provided it is not within five metres of the significant building.
  - vi) Removal of the outdoor garden shed at rear of building.
- 2. Removal, maintenance, repair or replacement of property boundary fencing, gates and posts, in the same location, retaining a similar level of visual permeability and no higher than the existing.
- 3. Removal, maintenance, repair or regrading of the external accessibility ramp in the same location.
