Fee to request review of decision to make or refuse to make exclusion determination

Fee for applicant to request review of decision to refuse to make an exclusion determination

Permit reviews

Review for a decision relating to a permit application for the subdivision, consolidation or realignment of a boundary of a registered place or the subdivision of a building on that registered place

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is less than \$10 000

Heritage regulations: 13(1)(b)(i); 20

Fee: 200% of 20 fee units

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$10 000 or more but less than \$20 000

Heritage regulation: 13(1)(b)(ii); 20

Fee: 200% of 75 fee units

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$20 000 or more but less than \$100 000

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$100 000 or more but less than \$250 000

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$250 000 or more but less than \$500 000

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$500 000 or more but less than \$1 000 000

Review for a decision relating to a permit application for works or activities to a registered place or registered object if the estimated cost of the works or activities is \$30 000 000 or more

Fee: 200% of 1149.1 fee units

Review for a decision relating to a permit application to carry out more than one class of works or activities set out in subregulation 13(1).

Heritage regulations: 13(2); 20

Fee: The sum of—

- (a) the highest of the fees which would have applied if a separate application had been made; and
- (b) 50 per cent of each of any other fee that would have applied if a separate application had been made.

Fee for review of Executive Director's determination in relation to refusal of a permit to demolish or destroy registered place or registered object

Fee: 40% of 885.8 fee units

Archaeological consent reviews

Review of Executive Director's determination in relation to an application for consent to uncover and expose-

- (i) an archaeological site or part of an archaeological site recorded in the Heritage Inventory; or
- (ii) an archaeological site or part of an archaeological site which is not recorded in the Heritage Inventory— in order to assess the condition and potential of the archaeology for the purposes of—
- (iii) constructing one domestic residential dwelling on a lot or allotment; or
- (iv) constructing an extension to one domestic residential dwelling on a lot or allotment

Heritage regulations: 23(a); 24

Fee: 45% of 20 fee units

Review of Executive Director's determination in relation to an application for consent to excavate—

- (i) an archaeological site or part of an archaeological site recorded in the Heritage Inventory; or
- (ii) an archaeological site or part of an archaeological site which is not recorded in the Heritage Inventory— for the purposes of—
- (iii) constructing one domestic residential dwelling on a lot or allotment; or
- (iv) constructing an extension to one domestic residential dwelling on a lot or allotment

Heritage regulations: 23(b); 24

Fee: 45% of 30 fee units

Review of Executive Director's determination in relation to an application for consent to uncover and expose-

- (i) an archaeological site or part of an archaeological site recorded in the Heritage Inventory; or
- (ii) an archaeological site or part of an archaeological site which is not recorded in the Heritage Inventory—

in order to assess the condition and potential of the archaeology for all other purposes

Heritage regulations: 23(c); 24

Fee: 45% of 50 fee units

Review of Executive Director's determination in relation to an application for consent to uncover and expose for an application for consent to excavate—

(i) an archaeological site or part of an archaeological site recorded in the Heritage Inventory; or

(ii) an archaeological site or part of an archaeological site which is not recorded in the Heritage Inventory—



for all other purposes

Heritage regulations: 23(d); 24

Fee: 45% of 72.4 fee units

Review of Executive Director's determination in relation to an application for consent to damage and disturb an archaeological site or part of an archaeological site for—

- (i) the construction of one domestic residential dwelling on a lot or allotment; or
- (ii) the construction of an extension to one domestic residential dwelling on a lot or allotment

Heritage regulations: 23(e); 24

Fee: 45% of 50 fee units

Review of Executive Director's determination in relation to an application for consent to damage and disturb an archaeological site for all other purposes, where damage is less than 50 per cent

Heritage regulations: 23(f); 24

Fee: 45% of 200 fee units

Review of Executive Director's determination in relation to an application for consent to damage and disturb an archaeological site for all other purposes, where damage is 50 per cent or more

Heritage regulations: 23(g); 24

Fee: 45% of 400 fee units

Review of Executive Director's determination in relation to for an application for consent to:

- possess, or dispose of archaeological artefacts, or
- to undertake geotechnical or soil testing, trenching or boring in order to install, maintain or upgrade service utilities, or
- a test archaeological excavation as part of a cultural heritage management plan, or
- for all other purposes for which a consent is required in relation to an archaeological artefact, archaeological site or a site recorded in the Heritage Inventory
